<b>Loft and Ladder</b> The cabin has a heavy steel ladder leading up to a loft. There is potential risk of falling while climbin in or out of the loft. Children need to be supervised at all times.	g
Wildlife The property is home to an abundance of beautiful wildlife, some of which can potentially be dangerous, such as rattlesnakes lurking around and under rocks. Guests should be careful when hik the property and avoid getting too close to wildlife, particularly rattlesnakes in the warm season!	ing
Rocks & Caves  The property hosts many large rock formations and some caves. The moss on the rocks can be very slippery. Children should be supervised at all times while climbing rocks and exploring the property. Wildlife, including rattlesnakes tend to linger in and around the rock formations and inside caverns.	
Seasonal Creek & Pond A creek runs through the property and there is a large pond on an adjacent parcel nearby. During raining season, water runs through the creek and could present potential danger. Children must be supervised around water at all times.	
Cows on Roadway & Curvy Dirt Roads  There is a ½ mile of dirt road leading toward the property as well as a ¼ mile long winding driveway.  The land is open range for cows. Precaution should be taken on curves and to avoid striking cows ar wildlife.	
<b>Deck and deck stairs</b> The cabin has a set of stairs leading up to the deck, which is approximately eight feet off the ground. Precaution should be taken so as to not slip on the stairs. Children should be kept from climbing the railings.	
Trees and brush The property has many large trees some of which are dead and have brittle branches. Others are fallen and home to reptiles and wildlife. Precaution should be taken when climbing or navigating around the trees and brush.	
Firepit  There is a warming firepit next to the cabin. This pit must not be used during windy dry summer months and must be monitored at all times. Trash should never be burned in the firepit and fires make extinguished when not actively monitored.	ust
